President's Report:

The board president thanked all for their efforts in working with the community. Overall the community is looking good.

Security Report:

Job One – Shannon Dixon

Security will be receiving additional training and orientation regarding greetings & first impressions at the front gate as well as knock and talks with residents, patrolling and gate control. There will be additional patrolling of the pool areas. There is still speeding on the community streets; security is reaching out to speeders and orientating them. Security uniforms will also be changing. Discussed that there are many incidents that do not get reported to the guards for them to be aware and handle the situation. Without them being notified they are cannot handle situations. There are certain instances where the local police have to be reached and they are not.

1. Haines City & Southern Dunes Traffic Patrol Agreement

1. Replacement of street signs

2. Asphalt Community Roads

Letters have been sent to the homeowners of Rebecca Drive, Park Place and Wedge Way regarding the tree trimming for trees near the curb so as not to interfere or create any inconveniences with the trucks when the truck beds lift to pour asphalt. Date has not been confirmed however it should be within the next 3-4 week. Residents of those streets will be notified so that they can be aware and make arrangements.

Bids were reviewed, and it was decided that the proposal from Tucker Paving, Inc would be approved due to pricing and previous work experience within the community. He will also be repairing the area on Southern Dunes Blvd that is coming up at no charge.

3. Repainting of Wall between Southern Dunes Blvd and The Estates

The painting of the top of the wall needs pressure washing and painting. Two proposals were considered with the final decision to accept Andrew Dawson's proposal. Paint will be a Sherwin Williams SW6354 Armagnac.
